Lake Marcel Community Club Park Rules

The parks at Beach 1 and Beach 2 are private park areas for use by LMCC Members and their guests. **All guests must be accompanied by a Lake Marcel resident.** To ensure a safe and pleasant visit for all, please be respectful of this property and to others using it by observing these rules:

- •Keep the gates closed at all times.
- No dirt bikes, pocket bikes, ATV's, Quads, motorized scooters or similar allowed (not even in the parking lot).
- •Don't tear up the grass or gravel in the parking lot with bicycles.
- •No alcohol, drugs, fireworks, foul language, pushing or rough behavior, or sexual behavior allowed.
- •No bicycles, skateboards or picnic tables on the docks.
- Skateboard and bike ramps are not allowed.
- No horses, loud music or camping.
- Dogs must be leashed or under voice control at all times. No dogs allowed in the swimming area.
- No littering.
- Children under 13 years old must be directly supervised by an adult.
- •Swim at your own risk. Beaches do not have lifeguards.
- •Children unable to swim need a personal flotation device (PFD).
- Washington State fishing regulations apply. A freshwater or combo license required for ages 15 and older.
- •Members must register with the office for parties larger than 25.
- •Unauthorized visitors will be asked to leave.
- •Stay off the lake when ice is present. Don't throw debris onto the ice.
- •Damage to LMCC property may result in permanent revocation of beach privileges.

LMCC property owners are responsible for the actions of family members and guests. Violation of any beach rules may result in possible fines to property owners and revocation of beach privileges for violators.

Please call the LMCC office at 788-2525 with questions or to report a violation.

Beach Reservation Policy (for groups larger than 25)

All Lake Marcel beach reservation applications require a LMCC homeowner to sponsor the event along with a fully-refundable \$200 deposit, provided no damages occur. The fees for reserving the park space start at \$50 for groups larger than 25 people. Please contact the office for rates if the group is larger than 25 People. Fees are used to cover costs of additional clean-up, garbage disposal, water and septic use, and park impact to the other neighborhood park users. Fees may be offset by monetary equivalent volunteer work by groups such as neighborhood litter pickup, etc. All work will have to be approved by the board prior to the event. Please make reservations at least 30 days in advance. As always, park reservations are for non-exclusive use (i.e., LMCC residents are always welcome to continue using the park even during an event). A sign will be posted with the homeowner's name, reserving a location for up to 4 hours. Reservation forms can be found on the website at lakemarcel.net or you can contact the office at 788-2525 for more information.

Community Crime and Covenant Violations

COVENANT VIOLATIONS & CRIMES reported within the last 3 months include: stolen generator (1), alcohol at Beach 1 (1), rooster on property (1).

SAFETY TIPS: Place indoor lights on a timer when you are away; install outdoor motion detection lights; don't keep valuables or garage door openers in your vehicle if parked outside your garage; lock your vehicle at night.

If you see suspicious activity after dark when Beach 1 is closed, you can call the Sheriff's Dept. **non-emergency number 206-296-3311**. State that you are reporting a non-emergency and would like to request the patrol car assigned to Carnation check on the park, located at 31600 NE 106th St. Carnation, for trespassers.

If you witness a crime be sure to report it <u>first</u> to the Sheriff's Department emergency number (911) and then report it to the LMCC office at 788-2525 or lkmarcel@frontier.com so we can alert neighbors. Water Quality & Fisheries Update by Allan Culverwell

Some of you may have noticed signs at Beach 1 and Beach 2 back in late June indicating that toxic blue green algae may be present again (for the third year in a row). Although the tests did show the presence of low levels of the cyanobacteria toxin in June, the good news is that we have not seen any further evidence of the algae and subsequent test have turned up negative for the toxin. The bad news is that our Lake is obviously susceptible to blue green algae blooms and we all need to do our parts to reduce the chances for future toxic blooms. While we can't control the temperature of the lake, even if you don't live on the lake you can help reduce the amount of nutrients that contribute to algae blooms by using safe fertilizers (no phosphates), washing your car where the runoff won't enter the storm drains, picking up after your dogs and maintaining your septic systems. It is a shame when we have to close the lake—especially on hot summer days, so please do your part to keep the lake safe.

You may have also noticed a large amount of milfoil in the lake this year—it is about as bad as anyone has seen in recent memory, so we have contracted with a firm (Aquatechnex) to treat the milfoil this summer. In fact by the time that you read this, the lake should have been treated and the milfoil should have already started to clear up. Signs will be posted warning folks to stay out of the lake (and avoid using lake water) for 24 hours after the treatment.

A number of community members have complained about swimmers itch this year—which is caused by parasites that are deposited in the lake by ducks and geese, so please be aware and take precautions to avoid this by following the guidance published on this King County website: http://www.kingcounty.gov/healthservices/health/ehs/ SwimmersItch.aspx

Closing out on a positive note, the lake was successfully stocked with larger Rainbow trout again this year—and reports from our fishing community are that the fishing is good. Please take advantage of this great resource and get out and enjoy the lake!

Washington Dept. of Fish And Wildlife Need You To Know...

- °When fishing at Lake Marcel, the WDFW requires anglers 15 and older to have a fresh water or combo license.
- °You can not fish with multiple poles.
- °Washington State limit on trout is 5; however **the limit for Lake Marcel is 2**. If bait is used then the first 2 catches count regardless of whether kept or released. Anglers at Lake Marcel are encouraged to keep all the bass they catch.
- olf using artificial bait, then you can catch and release all day long. **No live or power bait** can be used in Lake Marcel.
- ^oBoats must carry U.S. Coast Guard approved lifejackets for all adults on board & kids 12 and under must wear a lifejacket at all times.
- °Private lakes are subject to state regulations. Citations have been issued recently at Lake Marcel by a WDFW Officer.
- °Discarding fishing line in the lake presents a danger to wildlife.

Wow! This has been a busy July!

Though we thanked what I hope is everyone for their help during the 4th of July weekend events, I wanted to take a moment to highlight the help from **Summer Hopkins**, **Chuck Willis**, and **Bill Hart**.

This was my first year as Events Chair for the 4th – and I am humbled at the work it took to put this all together and awed at the help that came when it was needed. **Summer Hopkins** took on the most daunting task of the entire event – putting it together. **Chuck Willis** was essential in pulling together the group that set-up and tore down the docks for the display – as well as the tribal knowledge on how to get it done! **Bill Hart** loaned us the use of his dock/property/home for our fireworks crew – for <u>three</u> days. These community members were gracious and generous with their time, energy and resources. It is my great fortune to have had their help with this event.

As some of you know, this is the first year since we began our 4th of July fireworks tradition, some 9 years ago, that we have used a resource outside of our community to present the fireworks. This being the case, I hope to address a couple concerns here:

- The show went much faster than in prior years. That had to do with how some of the fireworks came pre-wired in the package. The total count of shells was similar to last year. However, the shells themselves were wired in bunches to provide spectacular multi-bursts. This was something that the pyrotechnic could not undo prior to the show and did not know until they began to unbox the explosives. So, while we had fast and furious multiburst bundles, she could not affect the timing.
- 2. The end of the show scare. Near the end of the show, the pyrotechnic used a flare to light any unused shells from the dock. The last one she lit burst very close to the water line. To the point that it looked as if she may have been caught in the explosion. Her team called an "all-clear" on the walkie-talkie just after that last burst but I should have announced it over the PA that she was OK. It caused concern with several members and I apologize for the worry that caused. Our tech later assured me that is a normal "thing," but I think we can agree that it was still alarming to the audience.

In spite of that scare, I hope you and your family were still able to enjoy the weekend in our beautiful community! As we look to next year, we will work to make it even better, easier, less work and an event to be remembered.

We had two community members (**Carrie Mussey**, **Brian Robertson**) help the pyrotechnic team for two <u>very</u> long days. Who knows, maybe we will soon have two more licensed pyrotechnics living among us who might be talked into putting on the show for us next year!

Architectural Control Update by Allan Culverwell

Just a reminder that the Lake Marcel Community Club Covenants require that all property owners request approval from the LMCC Board of Directors prior to cutting down or significantly altering any living tree large than 24 inches in circumference. If you live in a critical area (e.g. lakefront) you are also required to get a Clearing Permit from King County per King County Code 21A.38. Pre-approval for cutting or altering trees is not required for Emergency Tree Removal or Alternation—when a tree is dead or is an imminent threat of causing serious personal injury or significant property damage. However, you must notify the Board of Directors within three business days of any emergency tree work and provide photographic evidence that the tree(s) posed these risks. In order to preserve the natural setting of the Community, our covenants also require that all lots in the Lake Marcel Community Club maintain 50% of the trees outside the areas required for the house, driveway and septic. During any application review, the Board will take into account the existing tree coverage of the property and whether removing additional trees will violate the covenants. The Board may require the property owner to plant additional native trees as a condition of approval.

Dear Lake Marcel Neighbors -

If you hadn't heard, I am the LMCC Coordinator and my name is Laura Mills. I've lived in the Lake Marcel neighborhood with my family for 9 years. I am a mother and have 4 beautiful girls. We love our neighborhood. Last year at the last general meeting, the board announced they would be looking to hire a LMCC coordinator to help the volunteer board. I am that person. Recently I was voted in as the Executive Secretary on the board as well. As the LMCC Coordinator I do the things that the volunteer board members don't have time to do. They give a lot of their time, but there is always more to do. I am trying to fill in the holes. This year my list of "to do's" has been very long. I'm working to get them all done, and wanted to share a few things with you that the board and I have been doing for our community.

- In February I began interviewing and meeting with several landscape maintenance companies to take on the duty of maintaining our parks. In the end the board decided to hire JP Landscape. They come every Friday morning at 7am and are done by 10am. They usually start at beach 1. They mow the lawn, rake up dead leaves, branches and other debris, rake the sand, rake the bark chips under the play sets, pull weeds, blow off debris, edge the lawn and trim the grass around the dam and spillway. So far they have met our expectations.
- In May we hired a handyman to help replace Daryl, our former caretaker. Bart Maxcy is our new handyman. He is a Lake Marcel resident and a handyman by trade. He is not a full time or even part-time caretaker. He does all his work around the lake either before or after his "day" job. His knowledge and experience have been valuable. Bart cleans the bathrooms, empties the garbage, cleans the office, does general repairs, cleans off the buildings, cleans the grills, puts up community signs and various other jobs.
- o In June I interviewed and met with tree care companies to see about trimming our large trees at beach 1. We met with four companies and the board selected Tolt Tree Care to trim the trees at beach 1. We had over 20 trees trimmed, including the trees at the exit to the parking lot at beach 1. You can actually see the gate now. The trees around the entrance to beach 1 were trimmed and the large trees near the play set with the yellow slide were also lifted (by removing the lowest limbs) to prevent injury from kids running by.
- Also in June we hosted four different arborists to take stock of our trees' health. Arborists have varying opinions on the state of the trees in our beach, but for the most part the trees are healthy and we do not have any large trees that need to be removed at this time.
- With the dry weather and the intense heat our lawns have suffered at Beach 1. We currently use a sprinkler and hose system and pump the lake water up onto the lawn. This system is very labor intensive and our handyman hasn't had the time to keep up on all the watering required with the dry weather. Thanks to Art Grabb for stepping-in and volunteering many hours to help get the lawn watered. We are in need of more volunteers to help with the watering. - The board is discussing the possibility of getting a sprinkler system installed at Beach 1. I am currently looking for and interviewing sprinkler system companies for this job. FYI - We currently have a sprinkler system and timer at beach 2.
- Our dam was recently inspected by Washington State Dam Safety Engineers. The dam is in good working condition with no major issues. We will be trimming back the vegetation along the dam on the lake side and around the spillway to help insure visual inspections can be done on a regular basis more easily. We appreciate the help of Chuck Willis and Art Grabb and other volunteers for their constant attention to the dam.
- On August 7th, we will have a security detail in the area from 7-11pm. They will be patrolling the beaches and parks and approaching anyone who might be causing problems or not following LMCC rules. Please be aware this is a trial run and we hope to discourage inappropriate behavior in our parks by trying this approach.
- As always, Angie in the office of LMCC is constantly hard at work assisting the board and all of the neighbors with various needs. Angie is a wealth of knowledge and we are glad to have her in our office.

I hope this information gives you a better idea of what I do as the LMCC Coordinator and what your board, handyman and office staff are doing. There are a number of other things that are ongoing all the time, from dam inspections to milfoil weed charting and water sampling and testing. The board works hard to keep this a great area. We would love to hear your suggestions and concerns at our next board meeting every third Tuesday at the Carnation Fire Station at 7:30pm. Our next meeting will be on August 18th...I'll bring treats!

Please remember this is a covenant violation and members can be fined, and also have beach rights revoked. As members who share liability in our parks and lake, this issue affects all of us if someone drinks alcohol and falls into the lake or harms someone at the park. Please drink at home so everyone can enjoy the parks and lake safely.

You may have seen the new rescue/utility boats recently stored at Beach 1 near the swimming beach and also at Beach 2 near the lake. These boats are clearly labeled LMCC in red and remain unlocked with accessible oars, allowing members to guickly access them in an emergency. If you see someone misusing one of these boats please remind the individual these are for emergency use only. Thank you!
