


Lake Marcel Member Survey: August 2015



\$8,000 FOR 15 MINUTES! THERE ARE OTHER SHOWS AND IT HAS NOT REDUCE FIREWORKS AT LAKE MARCEL. The fireworks seem like an enormous expense for only 15 minutes. I see many other needs that go unmet. How about some of these ideas. We need an automatic sprinkler system at beach one, boat ramp at beach 2 could use some improvement (the bass fisherman use it extensively, the parking needs improving at beach 2, a horseshoe pit and volleyball court, summer program for kids which could involve activities and monitoring of behavior The money could also be used to improve the 4th of July event especially if the money was used to reduce the enormous time commitment of a few volunteers.

I think we need to review 4th of July Fireworks in a separate survey. I like the Community picnic and activities and we should maybe enhance those (laser show, live music, etc), but I seriously fear each year firework season roles around. We live in a forest community! Are fireworks a smart thing? ...and the past few seasons have been getting dangerously drier. What about all the pollutants we are putting into the lake? Lots of paper and cardboard laced with gun powder and phosphorous residues and by-products. This might not have been a problem in the past when LMCC was putting on a nice show with responsible fireworks, but lately, many around the Lake seem determined to outdo the LMCC show, with unknown products and methods. This cannot be helping our Lake Quality issues!! I think it's time to institute a BAN of fireworks (with Fines) for this community. It might be OK if we had LMCC putting on the only fireworks with safe products, but controls need to be enforced around the neighborhood. This years use of a security guard was a promising step in the right direction. I would hate to see Lake Marcel burned to the ground some year because of careless individuals.

The pyrotech people didn't seem to know their business. But my most significant complaint involves a total lack of good judgment in the private use of fireworks during a serious drought. The risk of forest / grass fire and possibly losing homes is too serious to ignore. I favor banning the use of private fireworks any July 4th in which the June average rainfall is less than 1/2 of normal (in this case, it was about 1/12th of normal), unless there was .15 inch July 1-3 - or some other reasonable formula.

I think that there should be email reminders to residents about not parking in or blocking the driveways of the people who live by beach 1.


